There will be an gallery for viewing the art, a silent auction on Friday and Saturday, and a live auction on Sunday.

### To enter, please:

- Sign the Art Show Rules on page 3.
- Fill out and return the Artist Information Sheet on page 4.
- Enclose your check to Nuke-Con or make payment via PayPal to payment@nuke-con.com.

Once forms and payment are received, we will send you confirmation of your space. You should hear from us within three weeks of sending us your payment.

You will need to complete a Control Sheet listing all your art and a Bid Sheet for each piece. You can find these at www.nuke-con.com/artshow.

#### **Important Dates and Times:**

- Thursday, September 26, 2019 is the last day we can receive your artwork by mail. Address it to Nuke-Con Art Show

  - Noon Live Auction begins
  - 3:00 pm to 5:00 pm Pick up any art that has not sold.

#### Art Show Rules

### **Fees**

- Panels (4'x4') and tables (6'x18") cost \$10 each.
- Half-panels (4'x2') or half-tables (3'x18") are \$7.
- Larger spaces (for large sculptures or pieces over 4' wide) are available by special arrangement.
- Nuke-Con will assess a 10% fee on all sales.
- Space will be reserved in the order we receive payment.
- Deadline for registration is September 26, 2019.

### **Original Artwork**

- Any pieces you offer for sale must be your own.
- Artwork in any medium will be accepted.
- Entries must be matted, framed or otherwise ready for display and each piece must bear your name and its title.
- If your work requires special handling (electricity, special lighting, etc.), please notify us in advance.

### **Prints and Reproductions**

- We accept prints and reproductions of your original art if they are signed and numbered.
- Each one must bear your name, the piece's title, and a price tag.
- If you choose, one copy of each design will be hung in the show (subject to the panel fee). Extra copies will go to the Print Shop.
- Print Shop pieces need not be matted (but they sell better that way), nor do they go to auction.
- There is no charge to place a piece in the Print Shop. Nuke-Con will assess its 10% fee on sales.

### **Preparing Your Bid Sheets: Bidding vs Quick Sale vs Live Auction**

You will need to complete a Control Sheet listing all your art and a Bid Sheet for each piece in the show.

- Minimum Bid is the lowest price you're willing to accept for the piece.
- Quick Sale is optional. You set the price that a buyer can pay for immediate sale. Once a Minimum Bid has been placed the piece is no longer eligible for Quick Sale.
- Once there are three written bids for your piece, it will go to the Live Auction.

### After the Show

#### **Payment:**

Checks will be made out to the Artist, unless otherwise requested, and will be mailed to Artists within a week of the convention.

#### **Unsold Art**:

- In-person pick up is from 3:00 to 5:00 pm Sunday.
- You may pre-pay for return shipping in your own packaging via the carrier of your choice. We will ship the first week after the convention. We suggest you consider insurance as part of the shipping cost. We will refund any excess pre-payment to the Artist.



Nuke-Con reserves the right to reject any work that does not follow the rules given above, that is not suitable for a family audience, or is hazardous (e.g., electric shock or spraying water).
